RE: IRS tax credit Manufacturer's Certification Statement

This is to certify that all Fabral metal roofing products produced with the following paint colors are eligible for the IRS tax credit of 30% of the metal roofing material only price; up to \$1500. Please note that even though the clear coated Galvalume that we sell is Energy Star approved, in our opinion, it does not qualify for this tax credit because it does not have an "appropriate pigmented coating that is specifically and primarily designed to reduce the heat gain of the dwelling unit"; as required by the tax code. The eligible metal panel colors, which meet or exceed the Energy Star requirements, are as follows:



Fabral, Inc. metal roofing panels produced from the above referenced colors and paint systems are Eligible Building Envelope Components that qualify for the credit allowance under § 25C. This tax incentive is part of the American Recovery and Reinvestment Tax Act of 2009 and applies to upgrades or additions to an existing home done during 2009 and 2010. It is not applicable to new construction. To be eligible, the metal roofing must be installed on a dwelling unit located in the United States and, at the time of installation, the dwelling unit must be owned and used by the taxpayer as the taxpayer's principal residence and the original use of this roofing component commences with the taxpayer. You may not exceed this maximum tax credit of \$1500 over that two year period for all eligible building envelope components. While we have taken great effort to portray this tax incentive correctly, we cannot provide tax advice and suggest you contact a tax professional with any questions specific to your situation.
